## GENERAL CONDITIONS

---

- 1) Valley Energy Inc. reserves the right to reject the Service Plan requested if, on inspection, it deems any portion of the equipment to be covered not to be in proper working order or unsuitable for servicing.
- 2) Replacement parts shall be the same, or equal, and all subject to the availability from normal sources of supply.
- 3) During the term of this agreement Valley Energy will provide dependable, prompt emergency service 24 hours/day, 7 days/week, 365 days/year. Non-emergency calls are not covered on nights, weekend and holidays. **Emergency service constitutes: No heat, fuel leaks, no hot water or dangerous situations. Service calls not covered under this agreement will be invoiced at prevailing rates including time and a half for service after regular service hours – 8:00 am - 4:30 pm Monday thru Friday.**
- 4) This Agreement does not cover the following:
  - A) Replacement of any defective parts or portions of the heating system not specifically included in the replacement parts schedule of this Agreement.
  - B) **The cost of labor and materials for work performed on the following equipment: Fuel storage tanks, heat piping and accessories, domestic hot water coils, oil line and valves, manual reset controls, tempering (mixing) valves, power venters, motorized zone damper systems, outside temperature sensors and associated controls, backflow preventers, temperature/pressure gauges, Logomatic control and sensors, any parts not specifically noted otherwise.**
  - C) Damage from restricted or plugged chimney, oil tanks and oil lines, poor draft conditions.
  - D) Obsolete parts, air cooling-air conditioning equipment, electronic air cleaners, kick space heaters.
  - E) Circuit breakers, blown fuses, thermostats not set properly or battery replacement.
  - F) Water feeder and low water cut off controls on steam heating systems.
  - G) Blue-ray/Blue Flame heating equipment and System 2000 Controls.
  - H) Air handlers, humidifiers, air cleaners and filters.
  - I) Induced draft systems and controls.
  - J) Remote monitoring systems.
  - K) Anti freeze - can be checked on request, for a minimal charge.
  - L) Related problems with the connection of anti-freeze.
  - M) When no part of the covered equipment is found to be at fault.
- 5) Valley Energy assumes no responsibility for heating failure or damage when a home or building is unoccupied or when unable to gain entry on requested delivery/service calls. Valley Energy shall not be responsible for secondary or consequential damages nor shall it be responsible for loss or damage due to or resulting from defective parts or from delays or failure to render service due to conditions beyond its control.
- 6) Valley Energy assumes no liability for oil tank failure, oil line failure, vent or fill pipe failure, fill or vent piping, resulting in petroleum spillage. Valley Energy assumes no liability for loss or damage due to inaccessible equipment. Example: Buried tanks, underground oil lines, equipment blocked by household storage, etc. Valley Energy assumes no liability for the condition and maintenance of the fuel tank or oil line leakage.
- 7) Valley Energy reserves the right to terminate this Agreement, without notice, if the purchaser permits any person other than an employee or authorized agent of Valley Energy to render service or adjustments to the equipment.
- 8) This agreement does not cover acts of God, fire damage, flooding or other water damage, electrical failure, defects in piping, radiation, domestic hot water accessories, etc.
- 9) This plan is not pro-rated or refundable, and can't be assigned without written consent.
- 10) This contract is only valid if the customer is an Automatic Delivery customer purchasing all of their fuel oil from Valley Energy.
